



It is produced 100% with recycled material, it is economical, sound-absorbing, non-slip, antibacterial, antistatic, long-lasting, resistant to water any numidity, insulating, easy to install and simple to maintain.

It is quick and easy to assemble, thanks to its click installation and is also suitable for "do it yourself" installation.

It is not afraid of oxidation, does not stain or discolor with direct exposure to the sun.

It is ideal for flooring all internal environments subject to high traffic, such as homes, shops, offices, hotels, gyms, restaurants, commercial areas.

Furthermore, it is switchen for flooring humid environments, such as bathroom, kitchen, garage, attic, cellar, attic.

VINYL FLOORING RECYCLED WOOD COLLECTION

Storage

The product must absolutely be stored with intact and closed packaging in covered and dry environments with a controlled temperature between 13°C and 29°C or at an average temperature of 21.1°C. If the product is stored outside of this interval before laying, it is advisable to acclimatize the material for the previous 48 hours in the same rooms where it will be laid.

Posa

It is advisable to let the material, in intact and closed packaging, settle for at least 24 hours in the vironment in which it will be installed. Inspect all planks for damage before installation. If you have any doubts regarding the fit or finish of the product or if there is damage due to impacts, tears or abrasions, contact the Company. We do not accept complaints for floors that have been cut and/or laid.

To minimize the variation in shade, open several boxes at the same time, mix and lay the boards, taking care to mix them.

The installation is floating only. Never fix the slats to the bottom when using the floating installation method

For installation in areas larger than 250 m2, an expansion channel of at least 16 mm must be provided along the perimeter.

The installation substrate must be consistent, stable, dry, clean and well welled.

Do not install on wood bases that sit directly on concrete or on wood or plywood used on con-

Cement screeds must be smooth, dry, clean and free from any foreign material such as dus ax, solvents, paint, grease, oils and old adhesive residues. The surface must be hard and compact and free of dust or flaking.

New concrete must be dry. The maximum humidity level allowed during installation is 65% en though the product is insensitive to humidity, it is important that it is controlled to avoid the formation of fungi and mould.

Underfloor heating permitted is only hydraulic. Electric ones are therefore not permitted and approved.

The product is quick and easy to assemble and can be installed with a click of a button.

Due to its very low thickness it can also be installed on pre-existing floors, without having to cut the doors.

It is simple to disassemble and is 100% recyclable.

However, for installation it is recommended to contact specialized person

The product is designed, manufactured and tested to meet all specific stand when installed in a workmanlike manner.

PAVIMENTO VINILICO COLLEZIONE RECYCLED WOOD

■ Advice after laying

- provide a doormat at the entrance to the home, kept clean, to remove dust and abrasive particles from the soles of the shoes
- thoroughly clean the soles of the shoes on the doormat
- · clean the floor surface thoroughly with neutral detergent products specific for laminates, or using a well wrung out cloth moistened with water
- place the felt pads under the feet of the chairs and furniture
- falling sharp or otherwise pointed objects cause scratches and gouges
- the stay of animals could cause the formation of furrows, scratches, stains and halos
- for objects and furniture with wheels, make sure they are equipped with rubber wheel
- the fall of embers and open flames causes the formation of burns
- too low floor humidity causes shrinkage, too high humidity causes swelling (thermal expansion)
- in the event of a fall/spill of water or liquids in general on the floor, immediately remove the liquid with an absorbent cloth and then proceed with cleaning the stained area with a cloth slightly moistered with vater

Cleaning and maintenance

For good maintenance of a vinyl floor, you observe the following precautions and tips

ORDINARY MAINTENANCE

- provide a doormat at the entrance to the house, kept clear to remove dust and abrasive particles from the soles of the shoes
- thoroughly clean the soles of the shoes on the doormat
- ordinarily remove the dust with a mop or an electrostatic dust-catching doth or with a vacuum cleaner
- usually wash the floor with a damp cloth (well wrung out) with water and a neutral or specific floor cleaner for laminate, non-foaming or aggressive
- never wash with boiling water and/or steam-producing appliances and never use solvents, bleach or ammonia
- avoid contact with any foamy product or substances, both chemical and natural, which are abrasive, acidic and corrosive

EXTRAORDINARY MAINTENANCE

After years and years of daily use, the floor may look worn or damaged.

For extraordinary maintenance of the walking surface it is advisable to contact expert and qualified personnel, who comply with the general safety standards and who carry out the typical phases of removing and replacing damaged elements.
